

## **PRIVACY POLICY**

Thank you for your visiting our website.

THE RELIGIOUS ORGANIZATION “ALL-UKRAINIAN SPIRITUAL CENTER “VIDRODZHENNIA” (hereinafter - the Religious Organization) has responsible attitude to the observance of the right of every visitor of our website concerning the confidentiality of personal data and takes measures to protect the information provided by you to us. We assure you that the Religious Organization makes every effort to protect the private information on the visitors of this website. This Privacy Policy describes how we process personal data using the Internet and other electronic communications networks, types of personal data which we are collecting, intents for which we use such personal data and parties to whom your personal data are disclosed. The use of this website is evidence of your acceptance of this Privacy Policy.

### **TYPES OF INFORMATION WHICH WE ARE COLLECTING**

The information you provide us on a voluntary basis

The Religious Organization may collect personal data such as surname, first name, patronymic, home address and e-mail, telephone number (“personal data”). If you register your personal profile, you may need to provide the mentioned personal data to complete the registration process. We may also collect payment information in case you carry out a charitable donation transaction. We can ask you to provide us with additional information (such as your age or gender) or information on your preferences and interests.

### **INFORMATION WHICH ARE AUTOMATICALLY COLLECTING AFTER YOUR ACCESS TO THE WEBSITE AND ITS USE**

In addition to personal data provided voluntarily by the parties of personal data, we automatically collect certain types of information when users are visiting the website of the Religious Organization. Such automated technologies may include the use of “Cookies” and web server logs to collect IP addresses. Collecting this information allows us to better understand and improve productivity, usability of the Website of the Religious Organization and its effectiveness, as well as to evaluate the effectiveness of marketing activities. We may use the services of third parties which assist us in collecting and processing the information described in this section and at the same time the abovementioned obligations apply to all third parties.

### **DATA BURST (COOKIES)**

Cookie is a data burst on a website designed for the purpose of accounting and for the convenience of users. Like other websites, the Religious Organization website uses this data burst for a different purpose, for example, to register the total number of visitors of our website on an anonymous basis. We may also use this data to save you in memory when you return to the website or your settings for using the website or to hold promotions and to help you work with the website suit to your needs. In such cases, we may receive information on your personal data from the cookie file.

Use the appropriate options in your browser if you do not want to save the cookie file, or set the option to notify when you receive the cookie file. If you turn off cookie options, you will reduce your facilities which you can use on our website.

## HOW WE USE THE INFORMATION PROVIDED US

Your personal data are used only for the purpose for which you provide the Religious Organization with such information. This information is also used to:

- provide you with the opportunity to conveniently use the website, send answers to your questions, complaints and comments;
- provide you with information on opportunities which may be interested for you, including the possibility to make a charitable contribution or special offers from us and our partners;
- improve the work of the website, administer and process data;
- verify the information you provide through our website and the validity of e-mail address provided by you;
- receive feedback from users of our website and notify you of changes occurred in this Privacy Policy and other policies;
- comply with the requirements of the current legislation, prevent the violation of privacy, legal norms or terms of agreements.

## SAFETY AND PROCESS OF MONEY TRANSFER

We use only secure methods and technologies for collecting and processing of personal data which we collect and store and make every effort to protect such information. The information on donors is stored in the donor database of the Religious Organization. Access to the database is limited to a certain number of employees of the Religious Organization who have agreed to provide the privacy of such information and data and solely for the reasonable purpose of such access or modification of the information available in the database. The Religious Organization on “vpay.org” site uses the Ukrainian payment system **LiqPay** which enable you to receive payments through a mobile phone, Internet and payment cards worldwide and the international electronic payment system **PayPal**. The Religious Organization does not directly collect the information on payment cards and does not have access to the information on payment cards which is transmitted online.

## DISTRIBUTION OF INFORMATION

The Religious Organization provides the necessary measures for the keeping of privacy and protection of personal data both for the party transmitting such data and for the party accepting such data. Of course, such information will only be used in accordance with the privacy policy. The Religious Organization may involve other companies to execute orders, conduct marketing programs, provide technical services for our websites and so on. These companies may have access to personal data if it is necessary to perform the mentioned functions. However, these companies may use personal data only to perform a specific task but not for any other purpose. The Religious Organization does not sell, transmit or disclose personal information to third parties. The Religious Organization reserves the right to use or distribute any information in order to comply with laws, regulations and legal requests, to protect the website integrity, to execute your requests and to cooperate in any investigation held by law enforcement agencies.

If you ever want to correct your personal data available to us or change your priorities in your contacts, you can notify us by post or by e-mail below. To view any of your personal information available to us or ask us to remove this information or stop using it further, please provide us

with the appropriate request. To view any personal information available to us concerning your child or ask us to remove this information or stop using it further, please provide us with the appropriate request.

#### CHANGES IN OUR PRIVACY POLICY

The Religious Organization will need to somewhat change its privacy policy from time to time, so we suggest you periodically review the changes. However, be sure that no changes will be retroactive and will not relate to the information collected earlier.
